	EJ reported to Governors -	
	Numbers are looking really healthy as of today we have 630. We do have 93 leaving from year 6 and only 65 coming in foundation. We are still doing tours for in-year transfers.	
	The most significant event of this term has to be OFSTED. We are delighted that the inspectors recognised that we are a Good school 'Withycombe Raleigh Primary is a friendly and happy school. Within its large school community, there is a positive and vibrant ethos. There were lots of positive comments in the report; inspectors recognised the 'swift and appropriate action to improve the curriculum' and 'The school has a strong offer for pupils' personal development'.	
	Attendance continues to be an issue at 95%. We had a meeting with Devon about inclusions and absence they were really happy with what we are doing.

	Favourable Ofsted 'Safeguarding is effective' – Lead Inspector commented that safeguarding at WRPS is robust / tenacious in safeguarding actions / follow ups. Staff knowledge was excellent. The Staff really shines in these situations.	
	Anna and I met the other day to discuss how information is shared and training. We discussed the induction program. When a new member of staff has been with us for 3 months we do a review we need to be more systematic and process driven. It's a good way to go through safeguarding a bit further.	
	Online Safety Policy to be completed / shared with Key Staff (inc James) before ratification	
	It's good that Ofsted recognise the time and effort that goes into this. It is such a big part of what we do. It's a big part of the inspection.	
	Are the younger children still segregated at play time? MS - no they come out in the field and they are supervised in a specific area. They are then scooped up and have the last 5 minutes of the playtime. We do need to do some work with our MTAs about how to supervise effectively.
